Notice is hereby given that the 12th Annual General Meeting ("AGM") of the members of the Company will be held on Monday, 09th September, 2024 at 11.30 A.M. (IST) through Video Conferencing ("VC")/ Other Audio Visual Means ("OAVC") to transact the Ordinary and Special businesses as set out in the notice of AGM.

In accordance with the General Circular No. 11/2022 dated December 28, 2022, 02/2022 dated May 05, 2022 read with General Circular No. 14/2020 dated April 8, 2020, General Circular No. 17/2020 dated April 13, 2020 and General Circular No. 02/2021 dated January 13, 2021, issued by the Ministry of Corporate Affairs and Circular No. SEBI/HO/CFD/CMD1/CIR/P/2020/79 dated May 12, 2020 and Circular No. SEBI/HO/CFD/CMD2/CIR/P/2022/62 dated May 13, 2022 issued by the Securities Exchange Board of India (SEBI), the electronic copies of Notice of AGM, procedure and instructions for e-voting/ joining the AGM and the Annual Report for the said meeting has been sent to all the members who have registered their email ids with the Company/RTA/ Depository participants on Friday, 09th August, 2024.

The Annual Report for the F.Y. 2023-24 along with the Notice of 12th AGM are also available on the website of the company at www.accentmicrocell.com; website of the Stock Exchange i.e. www.nseindia.com and on the website of the Depository i.e. http://www.evoting.nsdl.com/.

Further, pursuant to Section 91 of the Companies Act, 2013 and Regulation 42 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, the Register of Members and Share Transfer Books shall remain closed from Tuesday, 03rd September, 2024 to Monday 09th September, 2024 (both days inclusive).

The Company has provided the facility to its members to cast their votes on the matters set forth in AGM notice by electronic means through both the remote e-voting and e-voting at the AGM. Members are informed that the instructions for participating through VC and the process of e-voting, including the manner in which members holding shares in the Physical form or who have not registered their e-mail addresses can cast their vote through e-voting, are provided as a part of the Notice of the 12th AGM.

The remote e-voting period shall commence on Friday, September 06, 2024 at 09:00 A.M. (IST) and end on Sunday, September 08, 2024 at 05:00 P.M. (IST). Only the members whose name appears in the Register of Members/Beneficial owners as on cut-off date, i.e. on 02.09.2024 shall be entitled to avail the remote e-voting facility or e-voting during AGM. Members present in the AGM through VC/OAVM and who have not cast their vote on the resolutions through remote e-voting and are otherwise not barred from doing so, shall be eligible to vote through the e-voting system during the AGM, while the members who had already cast their votes by remote e-voting can participate in the proceedings of the 12th AGM, but shall not be entitled to vote during the AGM.
